- 1) **application** for participation in the conference using the form provided below;
- 2) **publication**.

Documents should be sent in two files (article and application), for example: Ivanov\_MI\_stattya.docx, Ivanov\_MI\_zayavka.docx.

Confirmation of registration for submitted materials entails receiving an electronic notification of their receipt within 3 days. If such a message is not received, please duplicate the information. Subsequently, the organizing committee conducts an internal review of articles and checks for plagiarism. Following this process, authors will receive details for payment of the organizational fee.

**The organizational fee** is UAH 120 and includes the preparation of **electronic** versions of the collection of scientific papers “Ukrainian studies in the European context” (No. 9, 2024), the conference program and the certificate of participation. For doctors of sciences, the publication is *free*. For foreign authors, the publication is *free*. For members of the PO “Innovative horizons of Ukraine”, the publication is *free*.

Conference materials will be sent to the authors' e-mails within three weeks after the conclusion of the conference. Additionally, the collection of scientific papers will be posted on the website <http://obrii.org.ua/usec/>.

## Requirements for the article formatting

The electronic version of the article (from 5 pages) should be prepared in MS Word format; page size – A4; page parameters – 2 cm on all sides; paragraph indentation – 1.25 cm; font – Times New Roman, size – 14, line spacing – 1.5; width alignment.

### Structure of the article:

- surname and initials of the author(s) – bold, Italics, size – 14; top right;
- academic degree (in full), academic title, position of the author(s) – Italics;
- place of work/study (official name of the institution in the nominative case) – Italics;
- title of the article – through the line, in capital letters, bold, centered;
- abstract (5-7 lines, in Italics) and keywords (4-5 words, in Italics) in Ukrainian;
- author's name, title of the article, abstract (5-7 lines, in Italics) and keywords (4-5 words, in Italics) in English;
- the main text of the article should have such structural elements: introduction, purpose of the study, presentation of the main material, conclusions;
- references – in italics, centered. The list of references in *alphabetical order*, prepared in DSTU 8302:2015. Foreign language sources are also formatted according to DSTU 8302:2015;
- if the article is written in English, the word "*Література*" is replaced with "References," and the entire reference list is formatted according to DSTU 8302:2015.

References to sources in the text should be given according to the model [2, p. 45].

In the article, it is desirable to make references to publications in previous issues of the collection of scientific papers “Ukrainian studies in the European context”. The archive of issues is available here: <http://obrii.org.ua/usec/archive>.
