

Invitation to publication

To publish an article in the collection of scientific papers “Ukrainian studies in the European context” (№8, 2028) please send an article in accordance with the requirements, and reference about the author by e-mail to the editorial board at ukrkonf@gmail.com by **March 28, 2024**. The file name should contain the author's full name, for example, `Ivanov_MI_article.docx`, `Ivanov_MI_reference.docx`.

Working languages of the collection: Ukrainian, English, etc.

Requirements for the article formatting

The electronic version of the article (from 5 pages) should be prepared in MS Word format; page size – A4; page parameters – 2 cm on all sides; paragraph indentation – 1.25 cm; font – Times New Roman, size – 14, line spacing – 1.5; width alignment.

Structure of the article:

- surname and initials of the author(s) – bold, italics, size – 14; top right;
- academic degree (in full), academic title, position of the author(s) – Italics, size – 14;
- place of work/study (official name of the institution in the nominative case) – Italics, size – 14;
- title of the article – through the line, in capital letters, bold, centered, size – 14;
- abstract (3-5 lines, in italics) and keywords (5-7 words) in Ukrainian;
- author's name, title of the article, abstract (3-5 lines, in italics) and keywords (5-7 words) in English;
- the main text of the article should have such structural elements as relevance, purpose of the study, presentation of the main research material, conclusions;
- references – in italics, centered. The list of references in alphabetical order, prepared in accordance with the State Standard of Ukraine (DSTU 8302:2015), should be given on a new line;
- if the article is written in English, the References block should be added, which contains a list of references in alphabetical order, prepared in accordance with APA style.

References to sources in the text should be given according to the model [2, p. 45].

In the article, it is desirable to make references to publications in previous issues of the collection of scientific papers “Ukrainian studies in the European context”. The archive of issues is available here: <http://obrii.org.ua/usec/archive>.

The editors of the collection carry out internal review of articles and check for plagiarism, after which the authors receive the details for payment of the publication fee.

The authors are responsible for the content of the publication. The editorial board reserves the right to reject articles that do not meet the requirements and topics of the collection, the principles of academic integrity, or contain significant technical errors.
